Eligibility Criteria

CHC’s Good Neighbor Awards are an opportunity for residents to recognize and be recognized by their neighbours. To be eligible:

- Nominees and nominators must be residents of CHC.
- Nominators and nominees cannot reside in the same household.
- The activity of a nominee must have taken place in the past year.
- If the nominee is under the age of 18, we will require consent from a legal guardian prior to publicizing the award.
- Nominations that are not aligned with CHCs vision and values are not eligible for consideration.
- Nominees whose tenancy is not in good standing are not eligible for consideration.
- Nominees are limited to one award win per calendar year

All award nominations will be reviewed by an Award Selection Committee (described in more detail below), and a single winner will be announced each month in CHCs resident newsletter. The winning nomination will be profiled the following month in CHC’s Resident Newsletter and could be featured in our annual report and other communications channels such as our website. We thank you in advance for taking the time to recognize and celebrate the Good Neighbours that make a difference in your community!

By participating in the Calgary Housing Company Good Neighbour Awards, either as a person making a nomination or receiving a nomination, participants agree to adhere to the following conditions. Each nomination shall be made for an individual not residing in the same household as the nominator. Only tenants in good standing are eligible for an Award. Each nomination must be limited to one nominator and one nominee. The Awards Selection Committee shall select only one winning nominee and one winning nominator per nomination cycle. The Calgary Housing Company reserves all rights to withhold awarding prizes or to modify the selection criteria at any time and without prior notification. Information provided in the nomination process may be used in future promotional materials by Calgary Housing Company. Participants may withdraw their nomination from the Calgary Housing Company Good Neighbour Awards by providing written notice to the Calgary Housing Company prior to the winners' announcement. Upon withdrawal, their nomination and related personal data will be excluded from the selection process and managed as per the Company’s privacy policy. Such withdrawal may lead to disqualification from the Program.
